**Position(s):** One (1) Engineer position for the sustAGE H2020 project  
**Project:** “sustAGE - Smart environments for person-centered sustainable work and well-being” (Grant Agreement number: 826506), funded under Horizon 2020, SC1-DTH-2018-2020.

**Description**

We seek one Developer/Engineer in IoT and sensing technologies. The candidate will participate in the R&D activities of FORTH-ICS in the context of H2020 project “sustAGE - Smart environments for person-centered sustainable work and well-being”, funded under Horizon 2020, SC1-DTH-2018-2020 and will work on IoT related aspects.

sustAGE is coordinated by FORTH-ICS and aims towards a smart person-centered solution that will function in real environments inside and outside the workplace providing: (i) workplace and health surveillance monitoring, (ii) personalized recommendations for physical and mental health improvement and (iii) decision support in optimizing workforce productivity via human to task/job allocation. The manifold contribution focuses on the support of the employment and later retirement of older adults from work and the optimization of the workforce management. sustAGE explores two industry domains with significant challenges and requirements: a) *Manufacturing* supported by Centro Ricerche Fiat (CRF) responsible for the research activities of Fiat Chrysler Automobiles (FCA), one of the largest European automotive industries and b) *Transportation & logistics* supported by Heraklion Port Authority S.A. (HPA) that manages the second most popular Greek port in passenger traffic.

The candidate will contribute in tasks regarding the implementation of the secure and privacy-preserving IoT ecosystem integrating different sensing technologies. More specifically the tasks include:

- Data Collection from various IoT sensors
- Secure interconnection of sensor devices and communication with the back-end system
- Data management, privacy preservation and integration
- System design and deployment

**Required qualifications:**

- o Bachelor's degree in Computer Science or related Engineering field.
- o Demonstrated experience in software development
- o Network programming
- o Programming languages: C++, python, Javascript, php,
- o Fluent oral and written English skills
- o Willingness and ability to work in a team, to learn, and to take initiatives
- o Communication skills
- o Physical presence at FORTH, Heraklion, Crete for the duration of the position
- o Completed military obligations (for Greek citizen male candidates)

- o Experience in computer vision and sensing technologies
- o Work experience in Web Development
- o Experience in Mobile App Development (iOS,Android)
- o Experience in system's security
