The candidate will participate in the R&D work of FORTH within the Panacea project. We are looking for an experienced software engineer to be part of the team designing and implementing an analysis framework enabling healthcare information secure sharing, cross-border, focusing on authentication,

interoperability aspects. The candidate will be also involved in performing dynamic analysis of cybersecurity frameworks in EU healthcare.

**Required qualifications:**

- University degree in Informatics, Computer Engineering or equivalent.
- At least 5 years professional experience in healthcare application development.
- Expertise in interoperability and integration aspects of hospital information systems.
- Expertise in large scale information systems design and implementation.
